

LIABILITY

The Art Association will insure all works accepted in to the exhibition only for the duration of the exhibit (May 2012 to June 2012). Entries will be insured for two-thirds the listed sale price with a **net maximum of \$1000 per item**. Shipping insurance for works accepted into this exhibition must be arranged by the artist and the shipping agent. The Art Association will not be responsible for any loss or damage to artwork before its delivery or after its pick-up from the Art Association building. The Art Association will not be responsible for minor scratches or dents to frames, breakage of glass, or scratches to plexiglas incurred during the run of the show.

SALES

In the event of sale, the Art Association is considered sole agent during this exhibit, and will receive a donation of **33 1/3 percent of the sale price**. The same percentage is expected on all sales for orders taken for additional prints during the show. Payment to the artist will be made no longer than 30 days after the close of the exhibition. No works marked "POR" (Price on Request) will be accepted. However, works marked "Private Collection" may be entered.

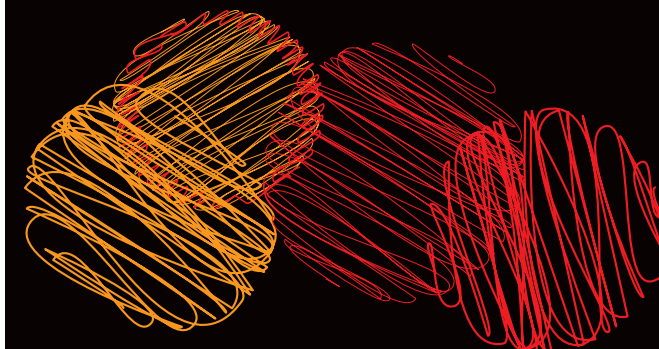

FEES

The non-refundable fee is **\$15.00 per entry for non-members, (AAH members pay \$12.50 per entry)**. Artists may submit up to two entries. Sculptors may submit two different views of a work, if desired. Make checks payable to the Art Association of Harrisburg.

ENTRIES

Entries must be submitted as 35mm slides or digital JPEG, high-resolution images on CD. Digital images should be no larger than 8.5" x 8.5". Label images with artist name, title, and top of image indicated. Slides/CDs of accepted entries become the property of AAH as a permanent record of the exhibition and for promotional use. Include a self-addressed, stamped envelope for notifications and return of slides/CDs not included in the show.

SUBMISSION DEADLINE

All entries must be postmarked no later than February 29, 2012. Notification of accepted or rejected works will be made by return mail.

ELIGIBLE WORKS

All original work in all media is eligible provided it has not been previously exhibited at the Art Association. Media categories for awards are Oil & Acrylic, Watercolor, Photography, Prints & Graphics, Sculpture & Ceramics and Other Media.

PRESENTATION

All watercolors, graphics, and photographs must be matted and framed under glass or plexiglass. No unframes or frames that leave the edges of glass exposed will be accepted. All oils and acrylics must be framed, or have the edges of the canvas neatly finished. All two-dimensional works must have screw eyes and wire in place, ready for hanging. Works without hanging hardware in place will not be hung. Wet paintings or frames will NOT be accepted. Unusual or experimental pieces may be accepted pending the approval of the exhibition and building committees. **Maximum size of any entry in any direction must not exceed 72" (outside dimensions of frame).**

DELIVERY AND RETURN OF ACCEPTED WORKS

Shipping instructions and charges will be mailed to all accepted artists. Work will be returned by G/B International Packing Service, at the artist's expense, at the close of the exhibition. The shipping deadline for accepted work is **May 4, 2012**. Return dates are **June 25-29, 2012**. Under no circumstances, may art be shipped directly to the Art Association.

Works may be hand-delivered to the Art Association of Harrisburg, 21 North Front Street, Harrisburg, PA, by **May 13, 2012**. Hand-delivered works must be picked up at the close of the show, from **June 22-30, 2012**.
