JUROR:

Scott Stulen, CEO and President of Philbrook Museum of Art, Tulsa, Oklahoma

Stulen is the former Curator of Audience Experiences and Performance at the Indianapolis Museum of Art, now Newfields, Project Director of martists.org at the Walker Art Center and Associate Curator at the Rochester Art Center. Now at Philbrook, Stulen is guiding the museum to become a recognized national model of sustainability, relevance, and community impact.

ENTRY FEES:

- AAH Members: \$12.50 per entry
- Non-Members: \$15.00 per entry
- Submission of up to two pieces only, fee is non-refundable

CONDITIONS OF ENTRY:

- Juried entries are open to all artists
- All media and styles welcomed
- Original work only
- Works previously exhibited at the AAH will not be accepted for entry
- Award medium categories include:
 - Oil & Acrylic
 - Watercolor
 - Photography
 - Prints & Graphics (Works on Paper)
 - Sculpture & Ceramics
 - Other Media (such as mixed media, fiber, jewelry, etc)

SUBMISSION PROCESS:

There are two ways to submit entires, either online through the AAH website or by mailing in a flash drive. Please note: Submission is a two-step process. All entry information and payment must be completed in the same format and on the same day.

 - In body of message include:
 1. Your mailing address
 2. Title, medium, size, price of each entry
 - Uploaded Images must be:
 1. PC compatible
 2. High resolution 300 dpi, JPEG format
 3. Label image files as title of piece

- Postal Service
 - Include:
 - Flash drive with image(s)
 - Information for each submission – title, medium, size, price
 - Your contact information
 - Self-addressed, stamped envelope if you wish to have CD/flash drive returned

 - Make checks payable to the Art Association of Harrisburg

DELIVERY OF ACCEPTED WORKS:

- Works may be hand-delivered or shipped to the AAH
- All costs of shipping or transportation are the responsibility of the artist
- Shipped deliveries
 - Accepted artists are responsible for insurance on shipped works
 - Must include return postage or FedEx/UPS prepaid labels
 - Must include reusable packing material

PRESENTATION:

- Selected works must be ready for professional presentation
- All two-dimensional works must have screw eyes and wire in place, ready for hanging
- Works without hanging hardware in place will not be hung
- Entry in any direction must not exceed 72"
- All works must be properly labeled

SALES:

- The AAH is considered sole agent during this exhibit, and will receive a commission of 33 1/3 percent of the sale price
- Payment to the artist will be made no longer than 30 days after the close of the exhibition
- Works marked "PC" (Private Collection) may be entered
- Works marked "POR" (Price on Request) will not be accepted

- The AAH will not be responsible for any loss or damage to artwork before its delivery or after its pick-up from the AAH building
- The AAH will not be responsible for minor scratches or dents to frames, breakage of glass, or scratches to Plexiglas incurred during the run of the show
